

**COOLMORE AUSTRALIA - STALLION NOMINATION AUCTION**  
**(All proceeds to go to the Rural Aid – Buy A Bale)**

Coolmore Australia is auctioning nominations to Pierro, So You Think and Rubick for the 2018 Southern Hemisphere Breeding season to support those affected by the recent drought in New South Wales.

**AUCTION RULES**

**Commences:**

[6pm, Thursday 23<sup>rd</sup> August, 2018]

**Finishes:**

[6pm, Wednesday 29<sup>th</sup> August, 2018]

**Auction items:** A single nomination each to PIERRO, SO YOU THINK & RUBICK for the 2018 Southern Hemisphere Breeding season (“Nomination”).

**Bidding Terms & Conditions:**

2. Bidders must provide a contact telephone number and e-mail address for a bid to be accepted.
3. All bids are to be made inclusive of GST.
4. If bids are received simultaneously, the bid first noted by Coolmore Australia will stand.
5. Bidders will be notified by e-mail that their bid has been accepted.
6. Bidding progress will be reported on the Coolmore website by 6.00pm each day and the highest bid submitted at that stage will be shown.
7. The Nomination purchased by the successful bidder (“the Purchaser”) will be subject to the terms and conditions in the attached Stallion & Agistment Agreement with Coolmore Australia (“Agreement”).
8. Coolmore Australia will invoice the Purchaser for the Nomination immediately after the auction and it will be stated that payment must be received within 14 days of the invoice being issued. If payment is still outstanding at 14 days after invoicing, the Nomination will be cancelled.
9. The Purchaser needs to be aware that Coolmore Australia accepts either walk-in or boarders with all normal transport, veterinary, farrier and daily charges to be paid by the mare owner.

## **10. Insurance**

- a. The Purchaser of the Nomination will have the option to take out insurance (which Coolmore Australia has arranged) to cover the situation where the stallion is unable to cover the mare due to accident, injury or illness, being deemed permanently infertile or death.
- b. The purchase price for the Nomination will be the amount bid to buy the Nomination less the cost of this insurance.
- c. Logan's Insurance will arrange insurance cover over the monetary amount of the winning bid. The insurance cover will cease when the mare has been covered three times, when the mare is confirmed in foal or at the end of 2018 season whichever is the sooner. Responsibility then lies with the Purchaser.
- d. The Purchaser will contract directly with Logan's Insurance for this insurance and will directly pay Logan's Insurance for the insurance.
- e. If the Purchaser chooses not to take insurance and either Pierro, So You Think and Rubick are unable to cover the mare due to accident, injury or illness, being deemed permanently infertile or death, Coolmore Australia has no obligation to the Purchaser of the Nomination.

## **11. Free Return**

- a. If a mare is covered by Pierro, So You Think and Rubick in the 2018 Southern Hemisphere Breeding season and does not go in foal or does not have a live foal that stands and suckles within 24 hours after it is born, Coolmore Australia will provide a free return to the stallion that the Purchaser used in the 2019 Southern Hemisphere Breeding season.
- b. This free return is subject to Pierro, So You Think and Rubick being available and being able to cover the mare and only applies for the 2019 Southern Hemisphere Breeding season.
- c. To be eligible for a free return the mare must be less than 12 years of age and have a good breeding record when covered in the 2018 Southern Hemisphere Breeding season.

## **12. Taxation Status**

- a. The Purchaser of the Nomination is buying a stallion nomination from Coolmore Australia and it will be invoiced as the purchase of a stallion nomination.
- b. It is the Purchaser's responsibility to determine the taxation status of this purchase.
- c. Please note that the payment would not be considered as a donation for taxation purposes by the Australian Taxation Office as it is payment for a service.
